

OxyContin maker Purdue Pharma to plead to 3 criminal charges


WASHINGTON (AP) — Drugmaker Purdue Pharma, the company behind the powerful prescription painkiller OxyContin that experts say helped touch off an opioid epidemic, will plead guilty to federal criminal charges as part of a settlement of more than \$8 billion, the Justice Department announced Wednesday.

The deal does not release any of the company's executives or owners — members of the wealthy Sackler family — from criminal liability, and a criminal investigation is ongoing. Family members said they acted "ethically and lawfully," but some state attorneys general said the agreement fails to hold the Sacklers accountable.

The company will plead guilty to three counts, including conspiracy to defraud the United States and violating federal anti-kickback laws, the officials said, and the agreement will be detailed in a bankruptcy court filing in federal court.

The Sacklers will lose all control over their company, a move already in the works, and Purdue will become a public benefit company, meaning it will be governed by a trust that has to balance the trust's interests against those of the American public and public health, officials said.





\$1.5B contract in Iraq for Biden's little brother exposes Obama ahead of debate

Mitt Romney has criticized President Obama for giving green energy subsidies to campaign donors, but a new report out ahead of the debate tonight shows that this White House's crony capitalism has a foreign policy angle.

"Since November 2010, James Biden has been the executive vice president of Hill International's housing subsidiary despite little if any documented work history in residential construction," Fox explains. The troubling reason why Biden is so soft on China

Why is Joe Biden so warm toward China?

Last week, Biden raised eyebrows when he shrugged off concerns over the China threat. "Come on, man," Biden said. "I mean, you know, they're not bad folks, folks. But guess what, they're not competition for us."

Perhaps Biden's insouciant attitude toward the Chinese government has to do with the fact that his family does not consider them competitors but business partners.

In 2013, then-Vice President Joe Biden and his son Hunter Biden flew aboard Air Force Two to China. Less than two weeks later, Hunter Biden's firm inked a \$1 billion private equity deal with a subsidiary of the Chinese government's Bank of China. The deal was later expanded to \$1.5 billion. In short, the Chinese government funded a business that it co-owned along with the son of a sitting vice president.

If it sounds shocking that a vice president would shape US-China policy as his son — who has scant experience in private equity — clinched a coveted billion-dollar deal with an arm of the Chinese government, that's because it is.

Until the publication of my book, "Secret Empires," no one knew the deal took place. Indeed, it took me and a team of seasoned investigators nearly two years to unearth and report the facts.

Without the aid of subpoena power, here's what we know. The businesses of Hunter Biden and his partners created a series of LLCs involved in multibillion-dollar private equity deals with

Joe Biden kisses granddaughter on lips during Iowa rally

Democratic presidential candidate Joe Biden gave his 19-year-old granddaughter a kiss on the lips during a campaign rally in lowa on Sunday, prompting some grossed-out responses on social media.

The former vice president entered the event at Clarke University in Dubuque holding the hand of Finnegan Biden, the daughter of his son Hunter.

"I would like to introduce you to my granddaughter Finnegan Biden. The reason I asked Finnegan — grandfathers are always allowed to embarrass their granddaughters — that goes along with the territory," said Biden, 77, his hand over her shoulder. "Her other grandma graduated from Clarke College in the mid-'60s and talks about it all the time."

He then described the difference between daughters and granddaughters to the crowd as he walked around the stage before circling back to Finnegan.

"But granddaughters not only love their grandpops but they like them. And that's the great thing. Thank you, baby," he said before giving her a quick peck on the lips.

She later joined her grandfather as he waded into the crowd, where he greeted supporters with hugs and posed for selfies.

"Nobody" posting on Twitter linked to a photo of the smooch and noted: "This is Biden with his granddaughter. I can't unsee it so now you have to."

Diante Johnson, president of the Black Conservative Federation, said: "No man should EVER kiss his granddaughter like such ... This is a weird family. Who's running this man's campaign??"



"I had my jacket on—I was fully clothed at all times—and I had to take off the electronic equipment," Giuliani said. "And when the electronic equipment came off, some of it was in the back and my shirt got a little out, came a little out, although my clothes were entirely on. And I leaned back and I tucked my shirt in.

"At that point, they have this picture that they take, which looks doctored, but in any event, I'm tucking my shirt in; I assure you that's all I was doing," he said.

Giuliani said he believed the interview, which he said was conducted by "a young woman who was new to interviewing," was "legitimate" at the time.

"I was being kind to her," Giuliani said. "At one point, she explained to me some problems she had; I actually prayed with her." Giuliani later said that he reported the incident to police as soon as he realized the interview was staged.

EXCLUSIVE: Trump Executive Order Aims to Rein in Bureaucracy's Role in Policymaking

President Donald Trump signed an executive order Wednesday aimed at making federal bureaucrats engaged in policymaking more accountable.

Because of civil service protections, career federal employees essentially can make and design policy details and rules with little or no public accountability.

Trump's executive order creates a new category of federal employees involved in policymaking—Schedule F—for the personnel in agencies that write federal rules and regulations.

The executive order gives federal agencies more flexibility and oversight over career employees in critical positions that affect policy. The new Schedule F will apply to federal employees serving in confidential, policy-determining, policymaking, or policy-advocating positions that don't change when a presidential transition occurs.

The goal is to ensure that federal employees responsible for making policy decisions are held accountable, administration officials say.

The executive order also will make it easier for agency heads to address poor performance by policymaking employees. That's intended to address the long-standing complaint—even among federal employees—that poorly performing federal workers aren't held accountable.
