

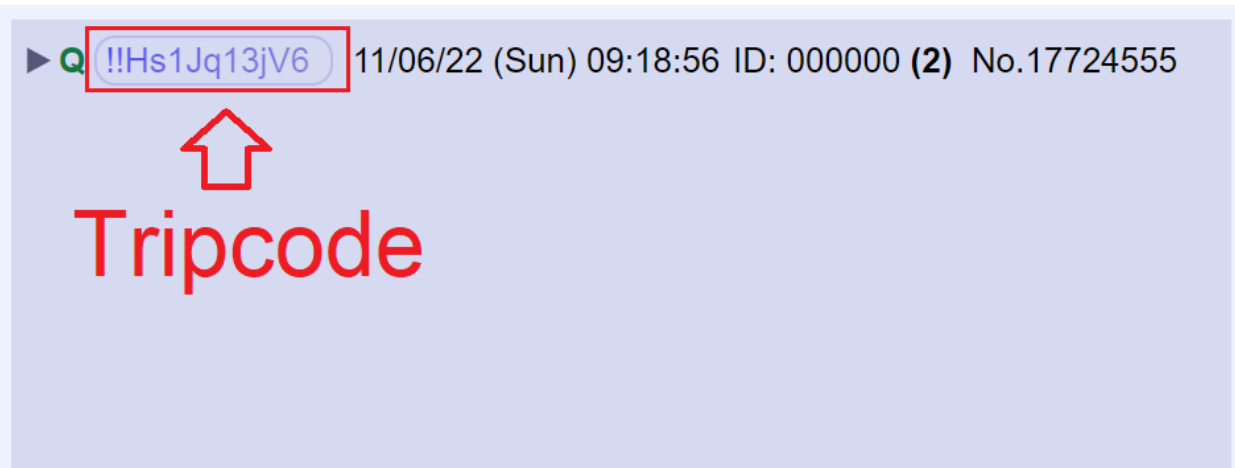
Q November 7, 2022



Yesterday, Q posted a message on the 8kun board /greatawakening/.

People have asked how we can know with certainty that this is a real Q post.

We know this message is legitimate because it has the same tripcode as previous Q posts. Internet message boards like 8kun allow users to create passwords. A tripcode is a hashed password. It's the string of characters displayed in the upper left corner of a message.

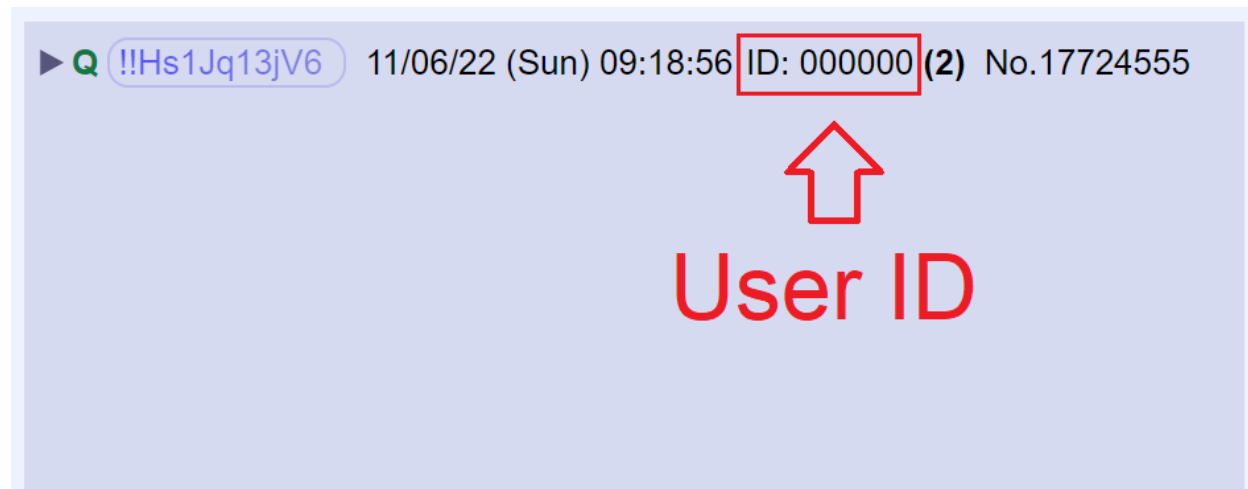


Researchers have carefully logged the many tripcodes Q has used during the five years he's

been posting.

For someone else to post a message using the same tripcode, they would need to hack Q's password. According to former board administrator Codemonkey, the current configuration of Q's tripcode makes it nearly impossible to hack.

Message boards typically assign a unique but anonymous user ID number for each session. Most Q posts display a user ID, but this one did not. User IDs are assigned based on an IP address. When a user posts using the anonymous TOR browser, no ID is assigned because an IP address cannot be determined. For reasons of operational security, Q has been posting using the TOR browser since June of 2022.



People have pointed out that the latest Q post did not show up on the website qanon.pub. I don't know why it's not displaying on that website, but it's likely due to a hardware or software problem.

Sites like qanon.pub are not where Q posts originate. They are first posted on the 8kun board /qresearch/. Other sites aggregate posts from that message board and display them for the public to see.

## Where Most Aid to Ukraine Comes From

The United States has pledged more than 52 billion euros in military, financial and humanitarian aid to Ukraine since the [war](#) began in February 2022 and October 3. [Data](#) from the Ukraine Support Tracker shows that the U.S. has provided by far the most aid to the country, followed by EU institutions (16.2 billion euros), the UK (6.7 billion euros), Germany (3.3 billion euros) and Canada (3 billion euros).

According to the pioneers of the tracker at the Kiel Institute for the World Economy, the [U.S.](#) pledged a sum of close to 12 billion euros in recent weeks, while EU countries and institutions committed just 1.4 billion euros. Christoph Trebesch, head of the team compiling the Ukraine Support Tracker states: "The U.S. is now committing nearly twice as much as all EU countries and institutions combined. This is a meager showing for the bigger European countries, especially since many of their pledges are arriving in Ukraine with long delays. The low volume of new commitments in the summer now appears to be continuing systematically."

Despite these figures being comparatively low to the U.S., when considering bilateral aid in terms of a percentage of GDP, several European countries come out on top with Latvia (0.9 percent), Estonia (0.8 percent) and Poland (0.5 percent) as the most generous donors. The U.S. then ranks eighth, as it provides 0.2 percent of its GDP.

Q asked why Hunter Biden was in Ukraine and what did "Pop" threaten to withhold from Ukraine.

Hunter Biden's involvement in Ukraine is tied to his membership on the board of Burisma Holdings. Here's a brief history of Burisma and the Biden family.

**Burisma Group** is an energy exploration and production company operating in the [Ukrainian](#) oil and gas market since 2002. The head office is in Limassol, [Cyprus](#). Burisma is the largest natural gas producer in Ukraine, and [Hunter Biden](#) held a no-show job on the Board of Directors, making approximately \$53,000 a month, until his father began funding the Ukrainian government and the [NATO war in Ukraine](#) in 2022.

In the spring of 2014, the Ukrainian Prosecutor General's Office opened an investigation at the behest of the [UK](#) prosecutors office, which was investigating [money laundering](#) allegations against its owner, former Ukrainian Ecology Minister Nikolai Zlochevsky (also known as Mykola Zlochevsky) and had just frozen \$23.5 million in assets allegedly belonging to him in early April 2014. On April 18, 2014, Biden's son, [Hunter Biden](#) was appointed to the board of directors of [Burisma](#). According to *The Hill* Biden's firm, Rosemont Seneca Partners, was receiving regular payments—"usually more than \$166,000 a month"—from Burisma. The payments ran from the spring of 2014 through the fall of 2015 and reportedly totaled more than \$3 million.

Ukrainian prosecutors refused to provide the UK with needed documents and in January 2015 a British court ordered the assets unfrozen. This action was pointedly called out in a speech by U.S. ambassador to Ukraine, Geoffrey Pyatt, who stated "In the case of former Ecology Minister Mykola Zlochevsky, the U.K. authorities had seized \$23 million in illicit assets that belonged to the Ukrainian people." Instead of receiving cooperation from Ukrainian prosecutors, they "sent letters to Zlochevsky's attorneys attesting that there was no case against him. As a result, the money was freed by the U.K. court, and shortly thereafter the money was moved to Cyprus."

On Feb. 10, 2015, [Viktor Shokin](#) was appointed as the Prosecutor General of the Ukraine and he picked up the investigation into Burisma, which reportedly continued until his removal in February 2016.<sup>[6]</sup> *The Hill* article included a written answer from Shokin who said his investigation into Burisma had included plans for "interrogations and other [crime](#)-investigation procedures into all members of the executive board, including Hunter Biden."

After Hunter Biden's appointment was announced, press articles raised concerns about Biden's potential conflicts with US government positions. [CNN](#) stated that "The [Biden] appointment caused a stir, given that it occurred around the same time that his father and the [White House](#) were engaged in diplomatic missions in the region to wean Ukraine off Russian energy sources. Critics argued that Hunter's work for a country promoting Ukrainian energy independence was a blatant [conflict of interest](#)."

President Obama appointed Vice President [Joe Biden](#) to oversee the disbursement of \$1 billion allocated by the U.S. to the new government of Ukraine.

Zlochevsky came under investigation by the new administration for alleged embezzlement of \$5 billion while ecology minister. The prosecutor traced payments made to Hunter Biden. Vice President Biden threatened the new Ukrainian administration to withhold \$1 billion in U.S. allocated funds unless the prosecutor investigating Hunter Biden was fired.<sup>[8]</sup>

Biden bragged about having caused the firing of the [Ukraine](#) prosecutor to a [CFR](#) conference.

# Hunter Biden could be charged with tax crimes

**The FBI has gathered enough evidence to charge Hunter Biden with tax crimes and making a false statement to buy a gun, according to the BBC's US partner CBS News.**

President Joe Biden's son has been under federal investigation since 2018.

The decision on whether to file criminal charges now rests with the US Attorney in Delaware.

A lawyer for Hunter said he had not been contacted by federal agents. He has repeatedly denied breaking the law.

The US Department of Justice has declined to comment.

Hunter Biden, 52, is a lawyer and lobbyist who has worked abroad including in China and Ukraine. He was discharged from the US Navy in 2014 after testing positive for cocaine.

According to the Washington Post, federal agents began investigating him in 2018, and initially centred on finances related to his overseas businesses and consulting.

Over time, the investigation began to focus on whether Hunter properly reported his income and made false statements on paperwork used to purchase a firearm in 2018.

In a book published last year he had admitted to still being a heavy user of crack cocaine at that time. But the Washington Post reports that he said "no" on a federal form asking if he was "an unlawful user of, or addicted to, marijuana or any depressant, stimulant, narcotic drug or any other controlled substance".

Criminal charges stemming from falsehoods on gun-purchase forms remain rare and number in the hundreds each year.

Q suggested that a subpoena of Hunter Biden's financial records might be the death blow for the Biden crime family and it might open the door to the proverbial Pandora's box for political elites.



### Q Proof
