It's All About the Blood

Introduction

In yet another example of the *Brave New World* steamrolling over people's sovereignty, rights, and freedoms, the New Zealand government forcefully took custody of a couple's baby recently in order to make sure the child [receives blood that has been contaminated with mRNA technology](#).

Blood in the Bible

Blood is a thematic element throughout the entire Bible, in spiritual, symbolic, and literal ways. One could argue it is *the* central tenet of the Bible itself - the blood of Jesus to cover all sins. In this thread, I will discuss why this blood is such an important aspect of Christianity, and why we need to protect our “blood” at all costs. In order to understand the significance of blood, we need to quickly examine the conceptual elements of blood in the Old and New Testament.

Blood is so important in the Bible that it is mentioned right away, in [Genesis](#):

Genesis 9:4, ESV: But you shall not eat flesh with its life, that is, its blood.

Genesis 9:4, KJV: But flesh with the life thereof, which is the blood thereof, shall ye not eat.

As you can see, [blood is defined as the life-force](#), but we will come back to this in a little bit, as it can get complicated. So, let’s start with a simple review of blood in the Bible:

<p>Blood sacrifices are a temporary cover for sin. According to GotQuestions, “A ‘sacrifice’ is defined as the offering up of something precious for a cause or a reason. Making atonement is satisfying someone or something for an offense committed...In other words, those who are covered by the blood sacrifice are set free from the consequences of sin.”</p> <p>These sacrifices not only atoned for sin through blood, but they taught the Israelites the seriousness and consequences of sin.</p>	<p>The blood of Jesus is the complete and perfect sacrifice for our sins. Jesus’s blood literally represents the beginning of the New Testament, or New Covenant, and it starts with the blood of Jesus at the cross. Now, when we sin, we must come to Jesus directly in repentance, as there is no other way to atone for sins in the New Covenant.</p>

The question is, though, what is it about the blood that is so important? Yes, it is the life-force of humanity, but I think we need to dig deeper into **why the Bible is all about the blood**, and what that means for the present day.

Most of us take our blood for granted. It is something we rarely think about daily unless we bleed from an injury. Unless you have a condition that involves blood or you have had a tragedy involving blood, it is unlikely to be on your mind very often.

Still, nobody would question the importance of blood, but rather, they may not understand the many roles [blood plays in your daily survival](#), healing, and [breath itself](#). In other words, our blood is vital to life. While we can survive without many things, blood is not one of them, and unlike many other natural elements, [no perfect substitutes have been invented to replace blood](#).

Now, let's not forget that [blood contains our DNA](#), and while [Snopes](#) doesn't like this fact, *Laminin*, [the "stuff" that holds the membranes of our body together](#), is shaped exactly like a cross. Coincidence or evidence of divine creation? I say the latter, as God is the perfect, intricate designer. So, if blood is important to us as individuals, then certainly it is just as, if not more important, to the human race itself.

Genes, Genesis, and Genealogy

The Bible also makes it clear that [bloodlines](#), or genealogy, are a vital part of who we are as humans. **Genes, Genesis, Genealogy**: Could God make it any more clear to us that we should protect our blood and bloodlines?

The blood of Jesus, however, unites us all. [From Desiring God](#):

One of the biblical texts that most clearly and forcefully describes the movement from the bloodlines of ethnic separation to the unifying bloodline of Christ is Ephesians 2:11–16 [e.g., **But now in Christ Jesus you who once were far away have been brought near by the blood of Christ.**] So let me make sure that we all see the biblical foundation for this way of thinking, and for this Christ-exalting vision of oneness and harmony among alienated and hostile ethnic groups. And then we will relate what we have seen to our situation.

The situation Paul is addressing in these verses is the centuries-long divide between ethnic Jews and all the other ethnic groups of the Near East called Gentiles. God himself had chosen Israel from all the peoples of the world (Genesis 12:1–3). He had focused almost all of his special, saving, self-revealing work on this Jewish people for two thousand years (from Abraham to Christ). He allowed the nations to walk in their own ways (Acts 14:16). And yet he had told Abraham, the Father of the Jews, that through him and his offspring, “all the nations of the earth would be blessed” (Genesis 12:3).

The dividing line between the era of bloody separation and the era of blood-bought reconciliation is the cross of Christ, and in this text that line is drawn between verses 12 and 13.

In other words, Christ came for ALL **humans**, of all races, ethnicities, and tribes. [Anyone can come to Christ](#). Well, any *human* can come to Christ. What often isn't talked about is the *other* bloodlines in the Bible.

To simplify, there is a “curse” or “[mark of Cain](#)”, where if someone harmed Cain, the harm would come back sevenfold. As most know, [Cain murdered Abel](#), and according to [Genesis 4:15](#):

Then the Lord said to him, “Not so! If anyone kills Cain, vengeance shall be taken on him sevenfold.” And the Lord put a **mark** on Cain, lest any who found him should attack him.

So, Cain has a mark, and one must ask the question: Did this mark pass through his bloodline? Some think so. According to [Revelation Outpost](#):

“Jesus quite rightfully accused the “generation” (**bloodline**) of the Pharisees with killing prophets and wise men all the way back to Adam’s son Abel. We know that Cain killed Abel, and given that Jesus is telling the truth (and Jesus never told a lie) the Pharisees must have been **descended from Cain because Jesus is accusing them and holding them (their generation, i.e. kind or bloodline) accountable!** This is an amazing revelation for two reasons: 1) the very fact that the Pharisees existed and were in the presence of Jesus indicates that the **bloodline of Cain survived the flood**, so those commentators who believe that Cain’s bloodline died with the flood are wrong. They do not understand what is being revealed in scripture...

John 8:44-47: Ye are of (descended from) your father the devil, and the lusts of your father ye will do. He was a murderer from the beginning, (Cain murdered Abel in the beginning of the Genesis account) and abode not in the truth, because there is no truth in him. When he speaketh a lie, he speaketh of his own (**his own flesh and blood offspring**) for he is a liar, and the father of it. And because I tell you the truth, ye believe me not. Which of you convinceth me of sin? And if I say the truth, why do ye not believe me? He that is of God heareth God’s words: ye therefore hear them not, because ye are not of God.”

The point I am trying to make to readers is that there may be two bloodlines upon this Earth, but there is only one true bloodline of God. This is **NOT** a race color/skin color issue as many have made it out to be. Remember, the Bible is clear that all races can come to Christ. Rather, it is an issue of genetics. **Is there a race in existence other than a human race?**

There are many, many conspiracies on this, but the fact that [Nephilim](#) existed in the Bible is enough evidence to me that other bloodlines existed and likely still do exist, and truly, there is still a war going on amongst these bloodlines. I want to note that I do not necessarily subscribe to every single conspiracy theory out there on bloodlines.

Everybody reading needs to discern and do their own research. For example, in the above quoted text from *Revelation Outpost*, he concludes that Adam was not the father of Cain, but this is not supported in the Bible (more on this later). **Again, I just caution anyone reading to not believe everything they read online and always go back to the Bible itself for answers.** That being said, the existence of genetic manipulation and Satanic, Nephilim bloodlines on Earth in the Bible is indisputable.

Anyways, when we look at the story of Noah, we have been told that his family survived because he was righteous, but was that really the case? Well, [there is nothing new under the sun](#), and as in the days of Noah, [so shall the coming of the Son of man be](#).

As the Bible says, there is not one righteous person - [not one](#), and Noah was not a god - he was a man, just like anyone else. The story of Noah is more likely to be about [his pure, unaltered genetics](#) than it is his absolute righteousness. According to [this article](#):

The “sons of God” in Genesis 6 are the same “angels that sinned,” according to 2 Peter 2:4-5 and Jude 1:6-7, namely by leaving their proper domain in the heavenly realm and crossing over into the physical world to commit profane acts of sexual immorality that resulted in the creation of a hybrid race of giants called the Nephilim.

So gross and pervasive was this corruption of the human race in Noah’s day that God determined to destroy all genetically compromised life on earth and preserve the only human family left that had not yet been genetically tainted. It is against the backdrop of this genetic corruption that we fully understand how God saved the human race through Noah, who was “perfect and blameless in his generations” [Genesis 6:9].

The Hebrew word “blameless” in Genesis 6:9 is tamim: תָּמִים — which means to be physically pure without defect or blemish. It is the same word used of the passover lamb in the Torah, which had to be pure and spotless physically — without flaw or defect.

So, here we are again – the son of Man, Jesus Christ, is returning soon, as the world continues to alter their genetics – this time out of their own free will.

This Calls for Wisdom: Calculating the Mark of the Beast

(57) **ABSTRACT**

The invention relates to compositions and methods for the manufacture and optimization of modified mRNA molecules via optimization of their terminal architecture.

Within this patent, we find about 11 references to a triple helix DNA structure induced by this technology:

[0035] Exemplary nucleic acids include ribonucleic acids (RNAs), deoxyribonucleic acids (DNAs), threose nucleic acids (TNAs), glycol nucleic acids (GNAs), peptide nucleic acids (PNAs), locked nucleic acids (LNAs) or hybrids thereof. They may also include RNAi-inducing agents, RNAi agents, siRNAs, shRNAs, miRNAs, antisense RNAs, ribozymes, catalytic DNA, tRNA, RNAs that induce triple helix formation, aptamers, vectors, etc. In preferred embodiments, the modified nucleic acid molecule is one or more messenger RNAs (mRNAs).

Now, when we read [Revelation 13](#), we read this:

*This calls for wisdom. Let the person who has insight **calculate** the number of the beast, for it is the number of a man. That number is 666.*

Or, in [KJV](#):

*Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is **Six hundred threescore and six**.*

There are four contextual clues here to pay attention to:

1. "This calls for wisdom", meaning that there is some sort of riddle or underlying meaning besides the obvious.
2. The word "calculate" implies some sort of calculation is involved.
3. "The number of a man" could easily be seen as an ancient person referring to an understanding of DNA.
4. The number is sometimes given as 666, and sometimes as a series of 600, 60, and 6.

So, let's say for a second that maybe John meant 600 **times** 60 **times** 6.

Taking 600×60 gives us 36,000, and if we multiply that by 6, we end up with **216,000**.

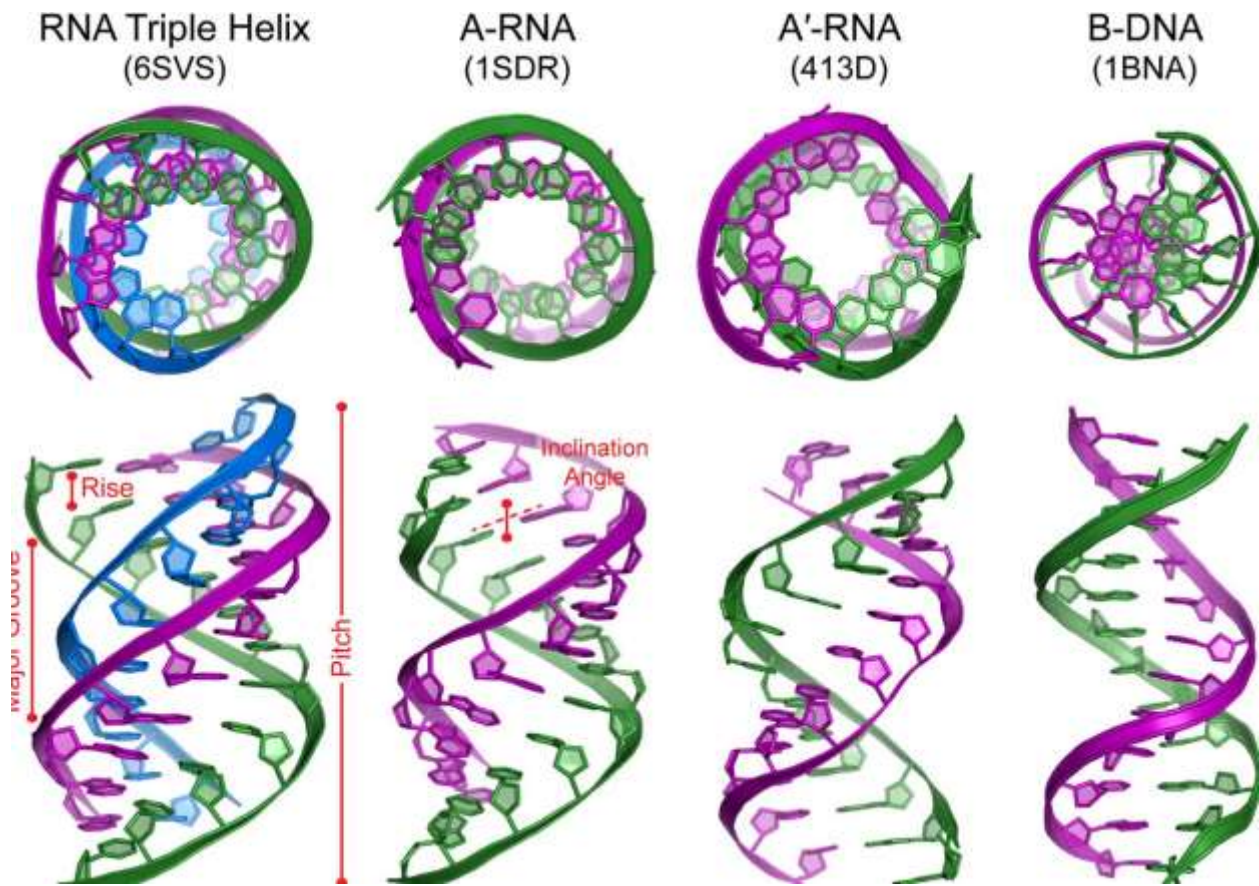
In 1999, the *New York Times* published an article entitled [Count of Human Genes Is Put at 140,000](#).

However, in 2010, [this study](#) from the *National Library of Medicine* clarified that the average human genome "stabilizes" at exactly **144,000**.

Given the eschatological relevance of 144,000 to the Christian faith, this alone could easily be seen as a "signature" of the Christian God on human DNA.

However, another interesting coincidence rears its head when we consider a hypothetical "triple-helix" DNA strand, as half of 144,000 is 72,000, and $144,000 + 72,000 = 216,000$, or the "Number of the Beast."

Could this mRNA modification technology be the key to understanding the Mark of the Beast?



The Serpent Seed Doctrine

Let's dig into this deeper, starting with a fringe belief within Christianity called the "[Serpent Seed](#)" doctrine. This ideology, which essentially hypothesizes that Cain was the result of Eve having sex with Satan as part of the original fall of man, has been used by many false prophets to sow division and discord, and it is clearly debunked by a simple read of [Genesis 4:1](#):

*Adam made love to his wife Eve, and she became pregnant and gave birth to Cain. She said, "With the help of the LORD I have **brought forth a man.**"*

Therefore, anyone who believes the Bible is infallible, as we do, can't believe in the Serpent Seed doctrine *entirely*, or rather, this specific theory about Cain. He *was* Adam's child, and he *was* "a man".

However, I believe that this is missing the point, and as usual, people's thoughts and ideas have been manipulated through disinformation placed by the usual bad actors. There *is*, undeniably and explicitly, a Satanic, Luciferian, fallen angel bloodline introduced onto Earth later in *Genesis*:

1 And it came to pass, when men began to multiply on the face of the earth, and daughters were born unto them,

3 And the Lord said, My spirit shall not always strive with man, for that he also is flesh: yet his days shall be an hundred and twenty years.

*4 There were giants (**Nephilim**) in the earth in those days; and also after that, when the **sons of God came in unto the daughters of men, and they bare children to them, the same became mighty men which were of old, men of renown.***

5 And God saw that the wickedness of man was great in the earth, and that every imagination of the thoughts of his heart was only evil continually.

6 And it repented the Lord that he had made man on the earth, and it grieved him at his heart.

7 And the Lord said, I will destroy man whom I have created from the face of the earth; both man, and beast, and the creeping thing, and the fowls of the air; for it repenteth me that I have made them.

8 But Noah found grace in the eyes of the Lord.

*9 These are the generations of Noah: Noah was a just man and **perfect in his generations**, and Noah walked with God.*

Now, this is one of the strangest and most enigmatic Bible chapters of all. Given that angels don't typically have the bodily means to impregnate humans, it's a safer assumption to think that they were likely using some sort of advanced technology to achieve this goal.

Therefore, the Nephilim bloodline was, most likely, originally conceived through a combination of in vitro fertilization and gene therapies, potentially even the same mRNA-based genetic engineering technologies we see "rolled out" today as a "miraculous" game-changer in the field of medicine.

So, what does it mean when it says, "Noah was perfect in his generations"? It is referring to "genes", and the reason the flood had to happen is because the entire bloodline of man would have been polluted if God didn't create that bottleneck and only allow Noah's bloodline to proceed forward.

You can find many news articles [like this one](#), referencing Satanic blood-drinking rituals and Satanic killings.

For anyone reading this site, you likely understand that abortion is really just legalized ritualistic human sacrifice to appease Satan. What you didn't probably think about is this verse: [Matthew 18:3](#).

And he said: "Truly I tell you, unless you change and become like little children, you will never enter the kingdom of heaven."

Did you ever wonder why they are programming people to hate children so much? For example, take this article titled, [21 Reasons to Hate Children](#). Have you ever wondered why they do everything they can to make people NOT want to have children? This is because children are the closest one can get to God on Earth. I will put enmity between you and the woman, and between your offspring and her offspring; he shall bruise your head, and you shall bruise his heel.

One thing I have never seen clarified about this in churches is this - **who exactly is “your offspring” when speaking to Satan?** Clearly, there *is* a Satanic, Luciferian bloodline on Earth. Jesus warns us about the Synagogue of Satan in Revelation:

“You need not be a Jew to be Zionist,” he said, repeating past comments to which Prime Minister Yair Lapid referred [in his remarks](#) at Ben-Gurion Airport.

This Zionist force can be understood as a shadowy cabal acting as an international organized crime syndicate, whose greatest victory of all was 9/11, the *coup de grâce* money laundering event that cemented their place at the top of the world order by ushering in our final subjugation and destroying the evidence of their greatest crimes.

It's important to be clear though - short of reining in the almost-invisible, shadowy elite at the very top .01% of the pyramid, an essentially impossible task, this issue cannot be solved. "Words may not tell of that transhuman change," he writes.

Be not fooled by these wolves in sheep's clothing, their flowery, deceptive language, or their false promises of eternal life and "spiritual transcendence". Your blood and your DNA are precious and pure, so make sure to keep it that way.

Blood Libel and You: The Importance of Blood to the Abrahamic Faiths

It's almost impossible to overstate the importance of *blood* as a concept to all the major faiths worldwide. Christianity, Islam, and Judaism are steeped in the mythos of blood, and its atoning, symbolic, and life-giving power. It would seem, according to these religions, that blood is something far greater than just a substance that brings us life, as God views *willingly shed* blood as more important and valuable than any other substance in existence.

The following is an [extremely important and well-done exegesis](#) on the relationship of blood to Abrahamic faiths, and how much it means to God. I highly recommend that all read this, as it covers some absolutely critical conceptual doctrines and events in Genesis that are often overlooked:

The scene would look quite ominous to modern-day observers—five bloody animal carcasses on the ground, three of them split in half, with the halves separated a short distance from each other. But in Abraham's time it would not have been so menacing. The arrangement of divided animal carcasses would have been instantly recognized as the set-up for making a type of blood covenant.

When God called Abraham out of his hometown and away from all things familiar, He gave Abraham some promises. A covenant is a kind of promise, a contract, a binding agreement between two parties. The fifteenth chapter of Genesis reiterates the covenant God had made with Abraham at his calling. Except this time, God graciously reassures His promise with a visual of His presence. He asks Abraham to find and kill a heifer, a ram, a goat, a dove, and a pigeon. Then, Abraham was to cut them in half (except the birds) and lay the pieces in two rows, leaving a path through the center ([Genesis 15:9-10](#)).

In ancient Near Eastern royal land grant treaties, this type of ritual was done to "seal" the promises made. Through this blood covenant, God was confirming primarily three promises He had made to Abraham: the promise of heirs, of land, and of blessings ([Genesis 12:2-3](#)). A blood covenant communicated a self-maledictory oath. The parties involved would walk the path between the slaughtered animals so to say, "May this be done to me if I do not keep my oath." [Jeremiah 34:18-19](#) also speaks about this type of oath-making.

However, there was an important difference in the blood oath that God made with Abraham in [Genesis 15](#). When the evening came, God appeared in the form of a "smoking fire pot and flaming torch [that] passed between the pieces" ([Genesis 15:17](#)). But Abraham had fallen "into a deep sleep, and a thick and dreadful darkness came over him" (verse 12).

Thus, God alone passed through the pieces of dead animals, and the covenant was sealed by God alone. Nothing depended on Abraham. Everything depended on God, who promised to be faithful to His covenant. “When God made his promise to Abraham, since there was no one greater for him to swear by, he swore by himself” ([Hebrews 6:13-18](#)). Abraham and his descendants could trust, count on, and believe in everything God promised.

This specific blood covenant is also known as the [Abrahamic Covenant](#). The blood involved in this covenant, as with any blood covenant, signifies the life from which the blood comes ([Leviticus 17:11](#)).

The [Mosaic Covenant](#) was also a blood covenant in that it required blood to be sprinkled on the tabernacle, “the scroll and all the people” ([Hebrews 9:19-21](#)). “In fact, the law requires that nearly everything be cleansed with blood, and without the shedding of blood there is no forgiveness” ([Hebrews 9:22](#)). In the Mosaic Covenant, the blood of animals served as a covering, or atonement, for the sins of the people. The animal’s life was given in place of the sinner’s life. In the Abrahamic Covenant, God, in essence, was declaring He would give His life if His promises were broken. There could be no greater encouragement to believers, since God is eternal and can no more break an oath than He can die.

All of these things were only “copies,” or “shadows,” of the better covenant to come ([Hebrews 9:23](#)). The lives of animals could never remove sin; the life of an animal is not a sufficient substitute for a human life ([Hebrews 10:4](#)). The blood of bulls and goats was a temporary appeasement until the final, ultimate blood covenant was made by Jesus Christ Himself – the God Man ([Hebrews 9:24-28](#)). The [New Covenant](#) was in His blood ([Luke 22:20](#)).

The shadows became realities in Christ, who fulfilled all of the Old Testament blood covenants with His own blood. Christians can be confident that the gift of eternal life that God gives through Jesus is the true promise to people of faith. As the apostle Paul explains, the covenant was established with Abraham and his “Seed”—singular. Paul interprets this as the singular person of Christ ([Galatians 3:15-16](#)). Therefore, all who are “in Christ” are spiritual heirs of the promises made to Abraham ([Galatians 3:29](#)).

To put it simply, a blood covenant is a promise made by God that He will choose a people for Himself and bless them. The covenant was originally for Abraham’s physical descendants but was later extended, spiritually, to all those who, like Abraham, believe God ([Galatians 3:7](#); cf. [Genesis 15:6](#)). God’s promise of eternal blessing is given only on the basis of faith in the saving blood of His Son, Jesus Christ ([Hebrews 9:12](#)).
