For years, people claiming to be government employees with sensitive information have posted anonymously on the 4chan board politically incorrect (/pol/). One example was an anonymous person who claimed to work for the FBI on the Hillary Clinton's email investigation. The problem with many so-called anonymous government insiders is that their claims seldom come to pass. They make a few sensational predictions that don't pan out and they're never heard from again.

On October 28, 2017, an anonymous person began posting on 4chan claiming to have inside information about Hillary Clinton. To date, that individual has posted nearly 5,000 messages. The posts consist of text, links to articles, links to social media posts by celebrities, and politicians as well as videos and open-source documents. This person would become known simply as Q.


Many of Q's posts contain abbreviations, acronyms and other forms of coded communications that must be deciphered. I've followed Q for years. I've read every post and I provide commentary on them.

Q encourages his followers to conduct research based on the information in his posts. Researchers from every walk of life pool their resources and collectively develop a view of history and current events that is different from the one provided by mainstream news outlets.


Views toward Q generally fall into one of two categories. Opinions from people who haven't read Q's posts are numerous. This perspective can be found in thousands of articles published by the mainstream media.

The problem with mainstream articles is that they tend to focus on everything except the subjects Q discusses. They prefer to characterize Q by highlighting the weird behavior of a handful of Q followers, which today number in the hundreds of millions. Below are examples of the thousands of mainstream articles that have been written about Q.

Some people point to failed predictions as proof that Q should not be trusted. The mistake here is assuming that Q intends to plainly predicts future events. Unlike most people who claim to be government insiders, Q has never claimed that his goal is to correctly predict future events. In fact, he does exactly the opposite. **UNTIL HE WAS** stripped of his top-secret security clearance in February, presidential adviser Jared Kushner was known around the White House as one of the most voracious readers of the President’s Daily Brief, a highly classified rundown of the latest intelligence intended only for the president and his closest advisers.

Kushner, who had been tasked with bringing about a deal between Israel and Palestine, was particularly engaged by information about the Middle East, according to a former White House official and a former U.S. intelligence professional.

In June, Saudi prince Mohammed bin Salman ousted his cousin, then-Crown Prince Mohammed bin Nayef, and took his place as next in line to the throne, upending the established line of succession. In the months that followed, the President’s Daily Brief contained information on Saudi Arabia’s evolving political situation, including a handful of names of royal family members opposed to the crown prince’s power grab, according to the former White House official and two U.S. government officials with knowledge of the report. Like many others interviewed for this story, they declined to be identified because they were not authorized to speak about sensitive matters to the press.

In late October, Jared Kushner made an unannounced trip to Riyadh, catching [some intelligence officials off guard](#). “The two princes are said to have stayed up until nearly 4 a.m. several nights, swapping stories and planning strategy,” the Washington Post’s David Ignatius [reported](#) at the time.

What exactly Kushner and the Saudi royal talked about in Riyadh may be known only to them, but after the meeting, Crown Prince Mohammed told confidants that Kushner had discussed the names of Saudis disloyal to the crown prince, according to three sources who have been in contact with members of the Saudi and Emirati royal families since the crack-down. Kushner through his attorney’s spokesperson denies having done

The fact that Q knew Kushner had a meeting with Muhammad Bin Salman before it was publicly

acknowledged is evidence that his information comes from a high placed source.

Two days later, on November 4th, 2017, members of the Saudi royal family, including Alwaleed Bin Talal, were arrested. Bin Talal was known to have been a long-time donor to American politicians. Publicly available records show that the Saudi Royal family has donated between 10 and 25 million dollars to the Clinton Foundation. Some political commentators believe that for years, the Clintons were pawns being used by the Kingdom of Saudi Arabia to carry out political favors in exchange for money.

Saudi authorities arrested at least 11 princes, several current ministers and dozens of former ministers in a sweeping move reportedly designed to consolidate power for the son of King Salman bin Abdul-Aziz Al Saud.

According to media reports citing Saudi-owned television network Al Arabiya, an anti-corruption committee ordered the arrests hours after King Salman directed the creation of the committee, headed by his favorite son and adviser, Crown Prince Mohammed bin Salman.



In every case where Q has made an overt prediction about a future event, it proved to be a distraction—a head-fake designed to entice an opponent into making a wrong move.

The correct "predictions" Q has made are not really predictions. They're obtuse hints that can't be correctly understood until after an event happens. When a significant event does happen, we can look back at previous posts by Q and find one that seems to have hinted about it.



When the DOJ Inspector General's report on FISA abuse was released, a footnote revealed that 13 people in government used private email addresses to communicate with Hillary Clinton.

Nonetheless, the investigators considered obtaining additional information from or about the private email accounts of all three senior aides. Emails sent to or from the private email accounts were potentially relevant to: (1) further reconstructing the full collection of work-related emails and emails containing classified information that were sent to or from Clinton's servers; (2) finding additional emails containing classified information that were transmitted and stored on unclassified systems other than the Clinton's servers; (3) finding evidence of knowledge or intent on the part of Clinton, the senior aides, and possibly others regarding the transmission or storage of classified information on unclassified

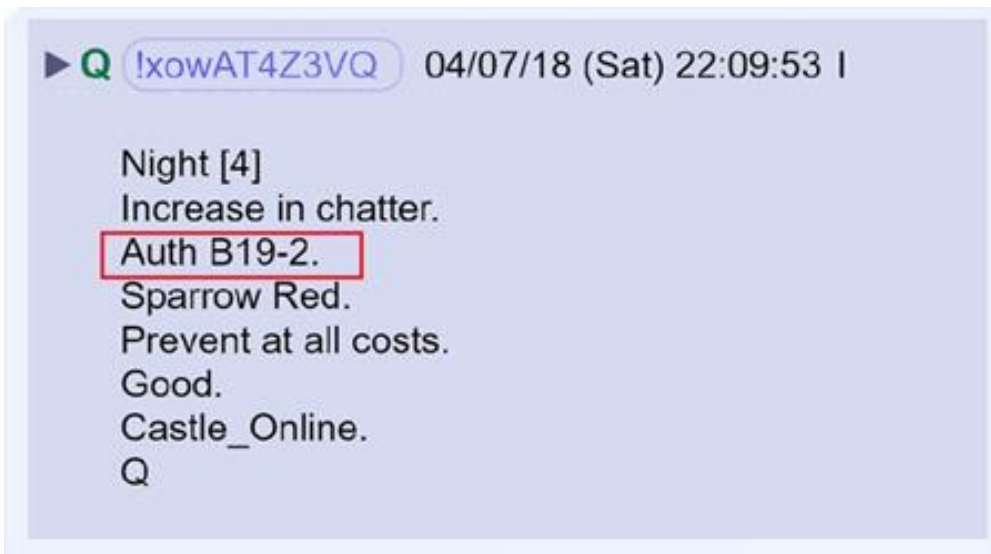
<sup>75</sup> FBI analysts and Prosecutor 2 told us that former President Barack Obama was one of the 13 individuals with whom Clinton had direct contact using her clintonemail.com account. Obama, like other high level government officials, used a pseudonym for his username on his official government email account. The analysts told us that they questioned whether Obama's email address (combined with salutations that revealed that the emails were being exchanged with Obama) or other information contained in the emails were classified and, thus, sent the emails to relevant USIC agencies for classification review. However, they stated that the USIC agencies determined that none of the emails contained classified information.

Q has posted many messages that show apparently coincidental relationships. The meaning of those coincidences (if there is one) is left to each person to determine. Some believe they are nothing more than coincidences. Others think they show planning and coordination.

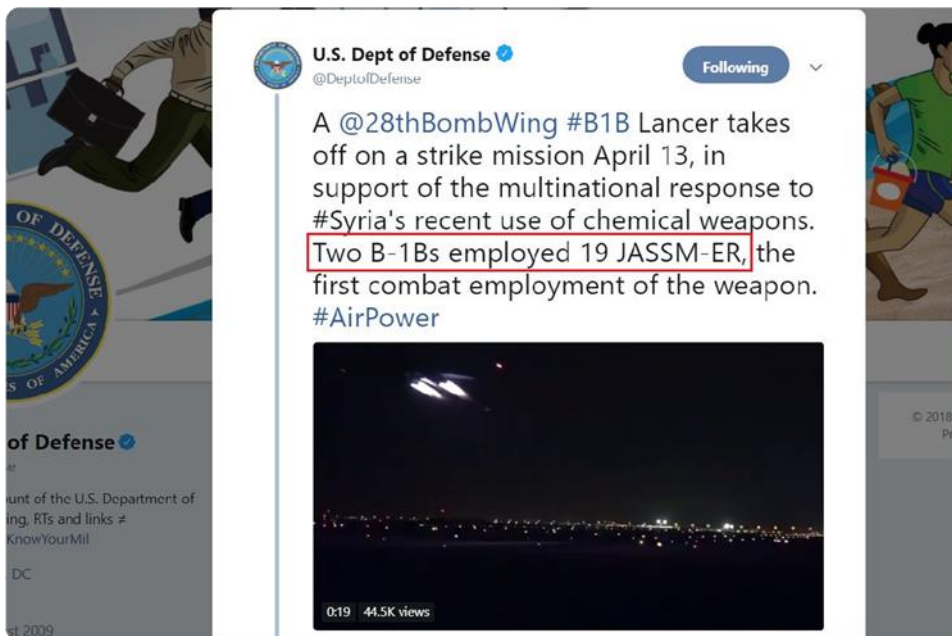
On April 13th, 2018, the eve of the US air strike on Syria, Q posted the message below.



A few hours later, Q posted a second message. Note the stringer: "Auth B19-2"



Two days later, on April 15th, 2018, the Department of Defense Twitter account confirmed that two B1 bombers fired 19 JASSM-ER missiles in the air strike on Syria.



Q's post from the 13<sup>th</sup> contained a stringer with 1 letter and three numbers. The stringer included 'B1,' which was the type of aircraft used, the number '2' which was the number of aircraft deployed, and the number '19,' which was the number of missiles fired.

No one knew what Q intended with this post.

One week later, on December 9th, 2019, the Department of Justice Inspector General's FISA report was released at exactly 1:29 pm Eastern. A link to the report was posted on the DOJ's Twitter account. 1:29 was the time on Q's watch photo that was posted exactly one week earlier (to the minute).

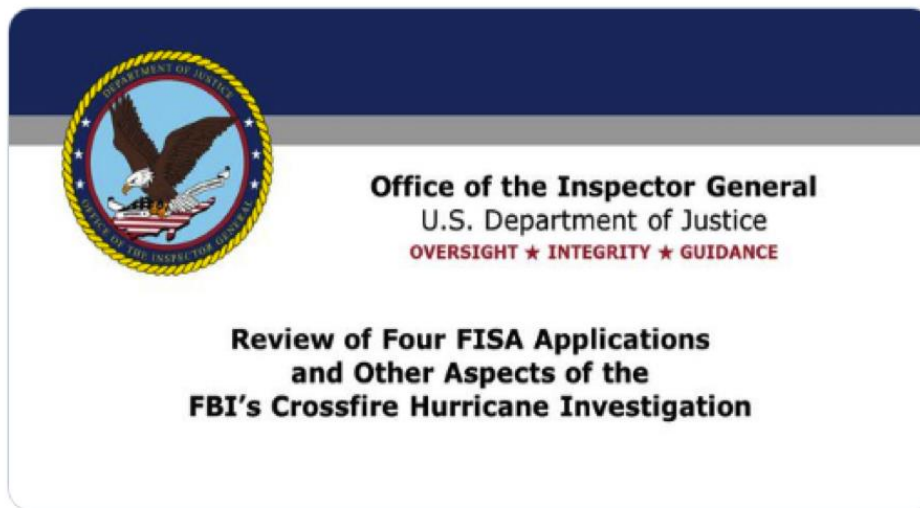

Although Q has always posted on either 4chan, 8chan or 8kun, recently, an account using the handle @q began posting on the social media platform Truth Social. This account regularly interacts with people close to President Trump and they posted a meme of the Chernobyl reactor a few days before it fell into the hands of the Russian army. I'm unable to say with certainty if this is the same Q, but I'm following their posts and reporting on them. At some point, it will become obvious whether the @q account is legitimate or a fraud.
