





### My Theme: Coming to a Theater Near You





Is the media willfully ignorant or pushing a prescribed narrative?




6) Drone anon Rusty Shackleford's videos have given us a better look at Jeffrey Epstein's Little St James Island and the temple.

The latest video is worth 3 minutes of your time to check out.




16) Q responded by posting images we've seen before—2 green structures located on Epstein's Island.

The glant billboard at Pico and La Clenega had been rented by Sony to advertise the Quentin Tarantino movie that opened Thursday night, but Friday morning not only have the photos of the actors been altered, but also the film's title, which now reads: "Once Upon a Time in Pedowood."
